APPROVAL OF THE MINUTES:

The Board reviewed the Minutes from the Pension Meeting held on August 05th, 2025, Trustee Faine made a motion to approve the minutes, which was seconded by Trustee McDeavitt. All Trustees voted yes, and the motion was passed 3-0.

The Board reviewed warrants 917 through 937. After review and consideration, Trustee McDeavitt made a motion to approve as presented, which was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 3-0.

ATTORNEY REPORT:

Attorney Garber began this Disability Hearing for retired member Aaron Kromrey by reviewing over the Service Disability Ordinance captured under City Ordinance 18.169 (c). The first order of business was to introduce all medical reports received in this matter into the record. After review and consideration, Trustee McDeavitt made a motion to accept all medical records and reports into the record, the motion was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 3-0.

After reviewing over the City Service Disability Ordinance Attorney Garber introduced Attorney Tonya Oliver who was representing retired member Aaron Kromrey, for her presentation. Attorney Oliver advised the Board Mr. Kromrey's injury occurred on 10/23/2022 as a result of a motor vehicle accident. Mr. Kromrey did continue to work in a light duty status after the accident. On10/25/2024 Mr. Kromrey reached MMI as described by the Workers Compensation physician. On this date, Mr. Kromrey's employment was terminated with the City of Boynton Beach. Mr. Kromrey filed for disability benefits from the Pension Board. The Pension Board sent Mr. Kromrey to two physicians for an Independent Medical Evaluations. Both Physicians concluded Mr. Kromrey was totally disabled from performing the duties of a Police Officer and this Disability was permanent.

After the presentation from both attorneys, the following three motions were made:

Trustee Faine made a motion that Mr. Kromrey was totally disabled, which was seconded by Trustee McDeavitt. All Trustees voted yes, and the motion was passed 3-0.

Trustee McDeavitt made a motion that Mr. Kromrey's disability was permanent, which was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 3-0.

Trustee McDeavitt made a motion that Mr. Kromrey disability was service related, which was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 3-0.

Attorney Garber advised Administrator Penque will work with the actuary and Mr. Kromrey to calculate his Disability Pension. Based on the motions above Mr. Kromrey is eligible to receive his first payment on 11-01-2025.
